## **Presentation – Rural Community Response Unit**

Chief Pederson gave the Rural Community Response Unit presentation on behalf of John Somerset, Inspector of Patrol Operations. The officers in this unit are part of Patrol Operations. This unit consists of one sergeant and five constables. The primary functions of members assigned to this unit are Search and Rescue; Off-Road/All Terrain Vehicle (ATV), and Snowmobile education and enforcement; Liaison Team for Protests and Demonstrations; and Police Liaison during labour disputes. Throughout COVID-19, these members have also formed part of the education and enforcement team. The Rural Unit

participates in Security Details when political leaders and other dignitaries are in the city. These duties are often short notice due to confidentiality.

# **Provincial Digital Evidence Management Solution MOU**

CAO Baiden reviewed the Provincial Digital Evidence Management Solution MOU for the Board. This new digital evidence tool will allow all stakeholders in the justice system to upload evidence. Chief Pedersen had previously notified the Ministry of the Solicitor General of GSPS's interest in participating in this solution. A Memorandum of Understanding is required as part of the onboarding process.

(2021-126) BOIS – CALDARELLI: THAT the Board enters into an agreement with the Solicitor General by way of an MOU that allows the Greater Sudbury Police Service to join the Provincial Digital Evidence Management Solution (DEMS) as provided for by Axon Public Safety Canada Inc. at a cost of approximately \$63,000 with funds to be drawn from the Communications Operating account.

# **Conducted Energy Weapon Procurement**

CAO Baiden reviewed the Conducted Energy Weapon Procurement Agreement with the Board. The current CEWs in use by the Service have reached their end of useful life and need to be replaced.

(2021-127) BOIS – CALDARELLI: THAT the Board enters into an Agreement with Axon Public Safety Canada Inc. to purchase/lease to own the CEW Taser 7 Fleet for GSPS at an estimated annual cost of \$264,981 annually (not including taxes) for a period of five years for a total cost of \$1,324,907 (not including taxes) with funds to be drawn from the Capital Financing Reserve Fund.

## Financial Report Year-End December 31, 2020

CAO Baiden reviewed the Financial Year-End Report for the year ending December 21, 2020. The audit by KPMG has now been completed and the year end concluded. It was noted that the year-end deficit related to COVID-19 unplanned expenditures and has been offset by the provincial Safe Restart Municipal Stream, which the City received.

# **Firearms Officer Agreement**

CAO Baiden reviewed the Firearms Officer Agreement for the Board. This agreement allows for the secondment of a GSPS member to the position of Firearms Officer. This officer participates in the administration of the Chief Firearms Office under the direction of the Chief Firearms Officer in accordance with the *Firearms Act*. The agreement provides for full salary and related compensation reimbursement.

(2021-129) CALDARELLI – SIZER: THAT the Board extends their Agreement with the Ministry of the Solicitor General operating as an Area Firearms Office for Ontario for the secondment of a Firearms Officer for an additional five year period to March 31, 2026.

## SIU Investigation – November 21, 2020

The Board received the Section 11 Administrative Review Report following the SIU investigation for a call for service on November 21, 2020, where a man was arrested for Public Intoxication. The review found that all policies and procedures were followed during this incident.

## SIU Investigation – June 25, 2019

The Board received the Section 11 Administrative Review Report following the SIU invesigation for a call for service on June 15, 2019, where a woman had filed a complaint of sexual assault involving one of her children. The complainant was highly agitated when officers arrived. After 40 minutes of verbal diffusion tactics, the complainant's actions caused concern for the safety of others and she was placed under arrest. She resisted arrest and was brought to the ground. During the arrest officers learned she was pregnant. The woman was brought to HSN where she was cleared medically and was released from police custody later that day. On June 29, 2019, the woman gave birth to a premature baby, who died the following day. The SIU found there was no misconduct by any GSPS member.

The Section 11 report included a review of the incident by the Indigenous Liaison Officer and an external partner with an Indigenous lens. This further review made recommendations; namely, revisiting of stakeholder information sharing protocols and cultural awareness and sensitivity training.

#### **CAPG Conference Attendance**

The Canadian Association of Police Governance is holding their 32<sup>nd</sup> General Meeting and Conference. The Board traditionally attends as it is a great opportunity for networking, discussion, and learning with Board colleagues across the country.

## **Report from the Chief**

The Chief's Report was circulated to members prior to the meeting. Chief Pedersen reviewed the many memos received from the Ministry of the Solicitor General since June. Some highlights of these updates include the Roadmap to Reopening, the Use of Force and Firearms Training Order, the Crisis Call Diversion program, the moving of Police Service Advisors to the new Inspectorate of Policing, and a COIVD-19 spending update.

## **Operational Updates**

Deputy Chief Weber was not able to attend this meeting of the Board. Acting Deputy Despatie reviewed the Operational Update with the Board.

Acting Deputy Despatie highlighted that over 6000 calls were taken by the 9-1-1 ECC in August alone. The ECC has 3 people in training and they are progressing well.

A/Deputy Despatie reviewed the work of the Criminal Investigations Division. 3 males were arrested for attempted murder; 3 others were arrested for a shooting on Lloyd Street; and a cannabis grow-op was busted and \$95,000 of cannabis was seized. He also reviewed the incident involving a 28-year-old man who stole a truck and drove erratically through the city, causing damage to multiple vehicles and buildings. The individual and truck were finally apprehended on Kukagami Lake Road with assistance from the OPP.

The Break, Enter, And Robbery (B.E.A.R.) Unit, Drug Enforcement Unit, and Internet Child Exploitation (I.C.E.) Unit all made multiple major arrests over the summer months resulting in multiple arrests made and charges laid.

Patrol Operations was busy over July and August with over 8000 calls for service handled, including 400 mental health calls for service. The Rural Unit ran a campaign with the MNRF focusing on marine safety, impaired operation, fishing regulations, and invasive species. The initiative resulted in 55 charges.

The Rural Unit was also busy monitoring anti-mask protests and labour disputes. Bike, marine, and ATV patrols were conducted throughout the summer and aided in 8 search and rescue events.
