## Matters Arising from In Camera Session – 10:00 A.M.

At today's closed meeting, the board dealt with the following matters: discussing/approving confidential matters pursuant to Section 44 (2)(d) of the CSPA.

#### Presentation – Intimate Partner Violence

Detective-Sergeant Lee Rinaldi gave a presentation to the Board on Intimate Partner Violence. He reviewed the social issues that contribute to and stem from the issue and how they affect the citizens of Greater Sudbury. He also reviewed the procedures GSPS follows in IPV investigations, and the community services the Service works with to ensure that victims are supported throughout the reporting and court process. He

D/Sgt. Rinaldi received some questions from the Board on the presentations. He noted that resources and funding for IPV programs only comes from province. He also noted that long-term supports for those experiencing IPV to transition from emergency shelters, etc. to other types of housing needs to be bolstered and supported more.

These community services are often under-supported and over-subscribed. Sudbury Area Victim Services is a local service that can help victims transition when experiencing IPV. They assist victims and provide a witness assistance program as well. This support does not end when court case is over.

Member Fortier notes that a commission was recommended in the Renfrew report in 2022. D/Sgt. Rinaldi says that the province has discussed the matter, but no commission has been formed as of yet.

Chair Sizer asks Chief Pedersen about restorative justice and how is used in Greater Sudbury, further asking what results come from the process. Chief Pedersen notes adult restorative justice is not an item that is provincially mandated or embedded in any legislation. It is for youth.

Member Fortier notes the Board should review Bill 173 for a possible motion of support.
